#### **Conclusion of the Share Buyback programme**

Following our communication on inside information of November 8th 2022 (with official register number 1647), in relation with the share buy-back programme (the "Share Buyback Programme", or the "Programme"), that was approved by the Board of Directors of Applus Services, S.A. (the “Company”), the Company hereby informs that, further to the latest acquisition referred herein below, the acquisition of a total number of treasury shares of 6,793,375, representing a 5% of the total share capital has been achieved, with an investment of 47,246,777.26 Euros, below the authorised maximum investment of 50,000,000 Euros.

The acquisition of treasury shares under the Programme has been communicated periodically, in accordance with article 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052, of 8 March 2016, supplementing Regulation on market abuse with regard to regulatory technical standards for the conditions applicable to buyback programmes and stabilisation measures ("**Delegated Regulation (EU) 2016/1052**").

The Share Buyback Programme has been therefore fully executed in accordance with its announced terms.

As informed on its launch, the Programme has been carried-out with the aim of reducing the Company's share capital by the redemption of the treasury shares acquired under the Programme. Such share capital reduction has been submitted for approval to the next Annual General Meeting of Shareholders of 2023, expected to take place on June 8, 2023.
